Before Installation

- Please familiarize yourself with the contents of these release notes for details regarding this version of MicroBiz, including any limitations.
- You must be on MicroBiz for Windows version 9.0 or above to apply this update. Please call our support group to arrange a manual update if you are on a version older than version 9.0.
- As with any change to your MicroBiz system, it is very important to complete a backup of your local and system files paths (BizWin and Business directories by default) prior to beginning an upgrade.

Bug Fixes

The following issues have been addressed in this release:

- Security option to Edit Customers from the front register (Issue 3367). User/password controls are now present after loading the Customer if security levels are set for the Edit Customer control.
- Customer Statements 'Print All' feature not functional (Issue 3337). MicroBiz can now correctly print all Customer Statements at once in a single action without requiring users to print preview each statement individually.
- Customer History window not closing properly (Issue 2606). Corrected a bug keeping the Customer History window open behind the front register form after reprinting from the Customer history (CH) window and when 'Recalc Cust Balance Due When Loading' is checked in transaction settings.
- Customer Statements not printing State and Zip Codes properly (Issue 3339). Customer Statements now properly print State and Zip Codes.
- Zmirrinv Error being experienced after each sale (Issue 3372). This error was introduced in 16.0 and was corrected in 16.0.1.
- Class cannot be instantiated error when loading items to a Purchase Order (Issue-3336). This error was introduced in 16.0 and was corrected in 16.0.1.
- Alias INV_TOP is not found for Liquor Shop Controller (Issue 3354). Bug introduced in 16.0.0 was fixed in 16.0.1.
- Full Screen Viewing of Customer and Product look-up form (Issue 3338). Version 16.0.0 did not allow for full screen expansion, or custom sizing of the Customer and Product Lookup forms. This functionality was added back in 16.0.1.
- Vendor SKU not being displayed properly in F3-Product look-up (Issue 3210). Vendor SKU is now shown correctly when loading this column to the F3 Product look-up table.
- Email addresses from Customer record are not automatically added to print dialog forms (Issue 3228). MicroBiz now automatically includes the Customer or Vendor email address saved in the database, based on the type of printout.
- Purchase Orders now display correct values when using Recalculate Cost based on extension, and selecting NEXT/PREV to view the next or previous item. (Issue 3191)
- Fixed an incorrect title of the Physical Count Report (Issue 3352). Report title changed back to 'Physical Count Report'.
- Xpresslink window not displaying properly or hiding when processing a transaction (Issue 3360). The Xpresslink window is now displayed in front of any other windows so that it is always visible while processing a transaction with X-Charge.

- Missing PO items or entire orders (Issues 3152). PO items and orders are now saving properly after editing and saving a PO or going to the edit PO / Receiving PO forms.
- Liquor Module not displaying full Customer credentials at the front register (Issue 3379). The Front Register Side Panel now displays the full set of Customer information, similar to the display on the Retail and Bike installations.
- Fixed price not showing correctly when customizable browse is not checked (Issue 3394). Corrected in 16.0.1.

Improvements and Enhancements

Improvements to version 16.0.1 of MicroBiz are as follows:

- **Modernization of User Interface on More Screens** – We have enhanced/modernized the appearance of multiple forms including the F9-Print Options, Purchase Orders, Management Hardware/Printer Options, Vendor Add/Edit, etc. These forms have been updated with modern colors/fonts, larger buttons and fields for better touch screen and mouse navigation and a more consistent layout/workflow.
- **Upgrade to Method to Email Receipts, Invoices and Customer Statements** – You can now email receipts, invoices and Customer statements directly from MicroBiz without having to use third party email software such as Outlook and Thunderbird. This greatly simplifies the process to email documents from MicroBiz. You also have the ability to set-up templates for each type of document - allowing you to enter and maintain text included with the documents emailed.
- **New Email Delivery Report** – We have added a new report showing all the receipts/invoices and customer statements documents that have been sent via Email, including what method was used to send the email. This allows you to see which customers have been sent which documents.
- **Integration with Electronic Signature Capture Devices** – MicroBiz is now integrated with a line of Topaz Signature Capture devices enabling you to capture and store an electronic signature for charge-to-account transactions, and all three custom tender options. This will work for credit card transactions as well, as long as there is no integration enabled with X-Charge, or BridgePay.
- **New Sales by Hour Report** - We have added a new report that displayed sales in your store by the hours of the day, and up to 16 hours per report. This is great to see which hours are the most busy, and can be used to optimize employee management.
- **Improved Printer Management** – We have upgraded MicroBiz to better integrate with the printer management capabilities included with your Windows operating system. As a result, the system no longer uses legacy Control Codes when setting up Printers.

- **Updated ShowMyPC Application** – The ShowMyPC application embedded in MicroBiz has been updated to the latest version, and will now install to its own folder upon its first usage. This will make it easier to update MicroBiz while remotely accessing your system.
- **Other Improvements** –
 - Updated the Transaction Settings form to allow for a save and continue, or save and exit function rather than having to save and reopen the form to make additional changes.
 - MicroBiz now allows you to enter a security setting (User Name/Password Request) for the clearing of an IIP/WIP/LA/QU on the front register.
 - We have added controls to allow/disallow the side panel on the front register to show the stock levels and committed values for the selected item(s).
 - Updated the Vendor Add/Edit maintenance tab key order.
 - Enhanced the Front Register Side Panel to display Tax 1 as a decimal while a Customer is loaded.
